AMENDED NOTICE OF DISCIPLINE HEARING

TAKE NOTICE that the Superintendent of Real Estate (the “Superintendent”) of the BC Financial Services Authority (“BCFSA”) will hold a discipline hearing under Part 4 of the *Real Estate Services Act* (“RESA”) on November 18-22, 2024 commencing at 9:30 am in the virtual Hearing Room at BCFSA’s offices located at **600 – 750 West Pender Street, Vancouver, British Columbia** to determine whether your conduct contravened the RESA, the regulation made under the RESA (the “Regulation”), or any rules made under the RESA (the “Rules”) in effect at the relevant time.

AND TAKE NOTICE that the allegations against you are as follows:

1. You committed professional misconduct within the meaning of section 35(1) and conduct unbecoming within the meaning of section 35(2) of the RESA in that:
 - a. you submitted, or allowed to be submitted, a mortgage application in or around October 2016 with falsified income information in relation to the purchase of a property located at [Property 1], Port Coquitlam, in which you represented yourself as the buyer, contrary to section 35(1)(c) [deceptive dealing] of the RESA and section 33 [duty to act honestly] (formerly section 2-4) of the Rules.
2. You committed conduct unbecoming within the meaning of section 35(2) of the RESA in that:
 - a. you submitted a mortgage application in or around October 2016 with falsified income information in relation to the refinancing of a property located at [Property 2], Port Moody.

AND FURTHER TAKE NOTICE that if the Superintendent finds you committed professional misconduct

and/or conduct unbecoming, the Superintendent must make an order against you, and may also order you to pay enforcement expenses incurred by BCFSA, under sections 43 and 44 of the RESA.

AND FURTHER TAKE NOTICE that if you do not attend the discipline hearing, the Superintendent may proceed with the discipline hearing in your absence and may make findings and orders under sections 43 and 44 of the RESA without further notice to you.

AND FURTHER TAKE NOTICE that you are entitled, at your own expense, to be represented by legal counsel and to participate in the discipline hearing.
